**PRECAUTIONS:**

- Do not inhale fumes and/or spray mist.
- Avoid skin and eye contact.
- Wear protective clothing e.g. suitable face shield and rubber gloves when handling and mixing the product.
- Wash with soap and water after use and accidental skin contact.

Thereafter, rinse the container three times with a volume of water equal to a minimum of 10 % of that of the container. Add the rinsings to the contents of the spray tank before destroying the container in the described manner.
- Destroy the empty container by perforation and flattening and dispose of it in a safe manner.

**DIRECTIONS FOR USE: Use only as directed.**

- **KNOX ROACH** is a flowable micro-encapsulated formulation.
- Due to its controlled release nature the product gives excellent residual action; however, effective knockdown may take up to 24 hours after application.
- **KNOX ROACH** is to be used for residual pest control in and around residential buildings including homes and apartments, in and around areas of industrial, institutional and commercial buildings including, but not limited to stores, hospitals, manufacturing plants, warehouses, schools and food handling establishments.
- **KNOX ROACH** can be sprayed on any surface which will not be damaged or stained by water.
- Under conditions of proper application, **KNOX ROACH** will not leave a visible deposit. However, if unevenly applied or sprayed to run off, a visible deposit may occur on some dark surfaces and may be wiped off with a cloth or damp sponge.

**Compatibility:**

- Do not use this product with oil.
- Thoroughly wash out spray equipment before using **KNOX ROACH**.

**Mixing Instructions:**

- SHAKE WELL BEFORE OPENING.
- When diluting, first half-fill the spray tank with clean water.
- Then add the required quantity of **KNOX ROACH**.
- Fill the spray tank with water to the required volume, while maintaining agitation to ensure thorough mixing.
- Maintain agitation or shake the applicator regularly during spraying to ensure even coverage.
- Shake or re-agitate the sprayer contents before use, if application is interrupted.
- If spray screens are used, they must be 50 mesh or larger.
- To facilitate pouring, wet the sides of the measuring cup with water, before ensuring **KNOX ROACH**.

**APPLICATION DOSAGE RATES:**

PEST	DOSAGE RATE	DIRECTIONS FOR APPLICATION
<b>Cockroaches &amp; Fish moths</b>	75 - 200 ml/10 l water	Apply spot application as a coarse spray or by paint brush to skirting boards, drawers, shelves, around water pipes, storage areas, closets, behind and under cupboards, refrigerators, sinks, stoves and similar areas where these insects hide.  Repeat <b>KNOX ROACH</b> treatment as needed, but generally will not be necessary more than once every 60 days.  The higher rate should be used where American cockroaches are prevalent.
<b>Ants &amp; Bedbugs</b>	75 ml/10 l water	<b>Ants:</b> Apply as a spot application by applying <b>KNOX ROACH</b> as a spray to skirting boards, window frames, cracks and crevices and similar hiding or habitation areas.  Apply to trails, around doors and windows and other areas where these insects may crawl or enter the premises.  For lawn treatment apply as an even overall drench using a high volume sprayer or watering can to ensure thorough wetting. Repeat as necessary. <b>Bedbugs:</b> Apply as a spot application by applying <b>KNOX ROACH</b> as a spray to places likely to be frequented by bedbugs such as into cracks and crevices and onto walls, bed frames and mattresses of where infestation occurs.  Do not apply directly to bedding. Repeat as necessary.
<b>Crickets</b>	200 ml/10 l water	Apply as a spot application by applying <b>KNOX ROACH</b> as a spray to skirting boards, behind and under cupboards and appliances.  Areas around doors and water pipes should be treated to prevent crickets from entering the premises. Repeat as necessary.
<b>Fleas</b>	400 ml/10 l water	Thoroughly apply <b>KNOX ROACH</b> as a spray to pet beds and resting quarters, adjacent crack and crevices, skirting boards, carpets and floor coverings, between and under cushions of upholstered furniture and other areas where these insects may be present. Entire carpets may be treated.  Applications to most surfaces should be as light as possible; approximately 2 litre spray mixture per 75 m <sup>2</sup> . It may be necessary to use a higher volume on long, dense, shag carpets. Old bedding of pets should be replaced with clean fresh bedding 3 days after treatment.  Animals should not be sprayed with this product.
<b>Houseflies &amp; Mosquitoes</b>	75 ml/10 l water	Make spot applications of <b>KNOX ROACH</b> as a spray to window frames, screens and similar areas where these pests may settle. Repeat as necessary.

- **KNOX ROACH** moet gebruik word vir residuele plaagbeheer in en om residensiële geboue insluitend huise en woonstelle, in en om areas met industriële, institusionele en kommersiële geboue insluitend, maar nie beperk tot store, hospitale, fabriekke, pakhuse, skole en voedselhanteringsfasiliteite nie.

Herhaal <b>KNOX ROACH</b> -behandeling wanneer nodig, maar sal oor die algemeen nie meer as een keer elke 60 dae nodig wees nie. Die hoër dosis moet gebruik word waar Amerikaanse kakkerlakke baie algemeen is
<b>Miere &amp; Weeluisse</b>	75 ml/10 l water	<b>Miere:</b> Wend aan as 'n koltoediening deur <b>KNOX ROACH</b> as sproei op vloerlyste, venster rame, krake en skeure en soortgelyke wegkruip- of broeiplekke toe te dien. Wend aan op spore, rondom deure en vensters en ander areas waar hierdie insekte loop of areas binnekom. Vir gras behandeling dien so egalig moontlik toe met 'n hoë volume sproeier of gieter om sodoende deeglike benatting te verseker. Herhaal indien nodig. <b>Weeluisse:</b> Wend aan as 'n koltoediening deur <b>KNOX ROACH</b> as 'n sproei, op plekke met waarskynlikheid van weeluisse soos krake en skeure en op mure, bedrame en matrasse of waar infestasië voorkom, toe te dien. Moet nie direk aanwend op beddegoed nie. Herhaal indien nodig.
<b>Krieke</b>	200 ml/10 l water	Wend aan as 'n koltoediening deur <b>KNOX ROACH</b> as 'n sproei, op vloerlyste, agter en onder laaikaste en toestelle toe te dien. Areas rondom deure en waterpype moet behandel word om te verhoed dat krieke areas binnedring. Herhaal indien nodig.
<b>Vlooie</b>	400 ml/10 l water	Wend <b>KNOX ROACH</b> deeglik aan as 'n sproei op beddens en rus-areas van troeteldiere, aangrensende krakies en skeure, vloerlyste, matte en vloerbedekkings, tussen en onder kussings van gestoffeerde meubels en ander areas waar hierdie insekte mag voorkom. In die geval van tapyte, kan die hele tapyt behandel word. Aanwendings op meeste oppervlakke moet so lig moontlik wees; ongeveer 2 liter sproeimengsel per 75 m <sup>2</sup> . Dit mag nodig wees om 'n hoër volume te gebruik in digter, langhaar matte. Ou beddegoed van troeteldiere moet vervang word met vars en skoon beddegoed 3 dae na behandeling. Diere moet nie met die produk besproei word nie.
<b>Huisvlieë &amp; Muskiete</b>	75 ml/10 l water	Wend kolbespuiting van <b>KNOX ROACH</b> as 'n sproei teen vensterbanke, skerms en soortgelyke areas waar hierdie insek mag voorkom aan. Herhaal soos nodig.
