

WARNINGS/WAARSKUWINGS:

The bait can also be applied in heaps of tablespoon quantities every one metre along paths around dense ground cover, shrubs or vegetable patches. Treatment should be repeated until all signs of snail damage has stopped.

Gebruik die lokaas droog en versprei ongeveer 25 g/m² teen laatmiddag wanneer slakke na reën of natspuit aktief is. Die lokaas kan ook in hopies van een eetlepel vol elke meter in paadjies rondom digte grondbedekkings of struik geplaas word. Toediening moet herhaal word totdat geen tekens van slakskade meer voorkom nie.
